The African continent has the highest urban growth rate on the planet which will need considerable investment in order to sustain & to clear up accumulated backlogs. At the same time, decentralization has resulted into increased responsibilities for local government, but in most cases, institutional reforms were carried out without the transfer of a sufficient level of resources, and local capacities in governance and project management are weak.

Objectives

 The main objective of the study is to clarify the debates around how best to finance African cities and to enlighten the choices of African decision-makers at the local and national levels.

The purpose of the activity is to define a group of actions aimed at the regulation of the *Areas of Special Social Interest/Special Social Interest Zones* (AEIS/ZEIS) in the municipality of Salvador, including (i) the elaboration of general urban legislation (AEIS/ZEIS occupied or urban vacant land); (ii) a social housing project in a vacant urban area and (iii) specific Regularization Plans according to the category of occupied AEIS/ZEIS.

Objectives

The proposal aims to implement actions for regulating the AEIS/ZEIS in Salvador and to replicate these initiatives for all AEIS/ZEIS in the municipality. The actions aim to improve living conditions, combat poverty and introduce control, social and urban management in the various occupied settlements. The specific objectives are to:

- Review existing urban legislation related to the occupied AEIS/ZEIS in Salvador and to prepare a new proposal;
- Review existing urban legislation for the implementation of new social housing projects and to prepare a new proposal;
- Complement the actions undertaken by the authorities in four informally occupied AEIS/ZEIS-type consolidated areas with a view to the implementation of the Regularization Plan.

Latin America and Caribbean – Argentina

Summary

The proposed activities cover three municipalities in the province of Buenos Aires. Through activities on a municipal and inter-municipal level, the Argentine Federation of Municipalities aims to produce development strategies and action plans to revitalize local and regional economies and to ensure sustained growth in identified sectors, generate employment and achieve greater poverty reduction.

Objectives

The overall objective is to design and apply replicable processes to elaborate Action Plans for Economic Reactivation at both municipal and provincial levels. The specific objectives are first to carry out City Development Strategies in three representative municipalities, Florencio Varela, General Alvarado, and La Costa. The second specific objective is to create a dialogue among local authorities and the provincial authority to identify measures which require support of the provincial government, and which contribute to economic growth of a significant number of municipalities in the Province and thus to develop a Preliminary Provincial Action Plan.

Activities

Municipal-level activities will be carried out simultaneously in all three cities. Preparations will be made by FAM by drafting TORs and procuring consultants. Consultants will proceed with collecting baseline data for national and municipal levels, conducting cross-sectoral surveys, and analyzing the collected data. Based on these findings, an analysis of drivers of growth will be undertaken, resulting in a strategy proposal and an action plan. FAM, the consultants, and representatives of the provincial government will carry out inter-municipal activities. Priorities will be established and incorporated into a Tri-Development strategy and Action Plan. Sessions on a provincial level will assess the strategy and action plan to ensure technical and financial feasibility and secure endorsement at the provincial level. Reports will be disseminated in English and Spanish.
