The objective of Phase II support is to further develop public consensus and/or technical details needed to implement the reforms and investments identified during Phase I.

- Adjustment of FSI and attendant development control regulation regime.

- Corporatization of public services.
- Strengthening consultation/communication for broader citizen participation in MTP.
- Establishing a Mumbai Observatory to improve monitoring and planning.
- Evolving a strategy to address climate change and mitigate environmental impacts of all development projects under the transformation agenda.

During Phase I, a broad framework and key priorities were established and the next steps are to carry out the specific priority actions through necessary studies, planning, and consultation as well as broadening and maintaining the overall public support.

Most of the priority actions, listed at left, require detailed work that must be carried out by line agencies with substantial resources. For each of the nine priority action areas, the activities to be carried out by MTSU with the Cities Alliance support primarily consist of framing studies, planning and consultation to establish the direction and parameters of such detailed work to be carried out, after the review and endorsement by the Empowered Committee, by the line agencies and to ensure coordination among them.

- Rejuvenating the economy outside the Absheron peninsula and create gainful jobs for the poor by institutionalizing the MDS process through developing a practical manual and by supporting the Permanent Parliamentary Commission for Regional Issues (PPCRI) to draft necessary legal reforms;
- Develop a model and methodological approaches to the MDS process tailored to the capacity of the majority of municipalities;
- Improve municipal finance and develop the technical capacity of municipalities to manage their own assets and deliver sustainable services to local populations; and
- Support the preparation of participatory, strategic plans in selected municipalities.

- Municipal Resource Profiling and value chain analysis will be conducted in 15 municipalities by local university students;
- Asset Management performance of municipalities will be assessed and recommendations for improvements will be made;
- Legal Review will be conducted to identify legal constraints to municipal development and recommendations made to PPRCRI to initiate policy reforms;
- Municipal Development Strategies will be prepared by 15 municipalities using participatory process;
- MDS Guide will be produced based on MDS experiences and disseminated by PPCRI to non-beneficiary municipalities.

Summary

The funding requested from Cities Alliance would be designated to a consultant to provide technical assistance to the Ministry of Cities in support of (a) the development of a National Housing Plan, including a National Urban Upgrading Strategy, with time-bound objectives and targets; and (b) a National Housing Subsidy Policy reflecting the need to rationalize the myriad of subsidies embedded in housing programs supported by the Government, including both on- and off-budget subsidies.

Objectives

- Support the development of the <u>National Housing Plan</u>—a concrete action plan with time-bound targets, policy actions, and investments—including a National Urban Upgrading Strategy; and
- Support the preparation of a proposal for a <u>National Housing Subsidy Policy</u>, based on baseline data and analytical work underway to identify and map the existing housing subsidy policies in Brazil. The objective of the national housing subsidy policy would be to develop a well-targeted program to benefit the poor while making the most effective use of public resources (i.e. rightsizing subsidies and leveraging subsidies to maximize owner contribution and market-based lending).

Activities

During a 12 month period, a consultant will support the following activities:

- Elaboration of a National Housing Plan inclusive of a Slum Upgrading Strategy with time-bound action plans
- Preparation of a National Housing Subsidy Policy

To curb the sharp increase of slums in the country and meet MDG Target 11, the Government of Costa Rica has allocated USD\$30,000,000 for the implementation of countrywide neighborhood improvement programmes in 2006-2010. This application aims at supporting this programme with a national slum upgrading policy focusing on citywide slum upgrading activities in select cities, including the capital city.
